- 2. **Employment at Will:** I understand that any employment I might obtain with J & J Service Solutions is at will. I further acknowledge that company policies, manuals or other similar documents are meant to be explanations of current benefits or programs that are subject to change and they do not change the terms of my at-will employment. I also understand that only senior corporate officers have the authority to change my at-will status, which any change must be in writing and signed by an officer, and that at any time or for any reason, I may resign my position or J & J Service Solutions may terminate my employment.
- 3.
